If the entry uses any third-party models, textures, music, sound effects, fonts, images, videos, AI-generated content, or other materials, the participant(s) must ensure that proper authorization has been obtained and must indicate the source and usage method as required by the Competition.

4. The School confirms that the participating students must submit complete entries and related materials as required by the Competition, including but not limited to the final video, Blender scene file, rendered images, creative concept, story outline, AI tool usage records, and representative prompts. All submitted materials must be truthful, complete, accessible, and in the specified format.
5. The School understands that all deadlines shall follow the time announced by the Organizer. If a competition entry or related materials are submitted late, incomplete, corrupted, inaccessible due to invalid links, or not submitted as required, the Organizer has the right to cancel the relevant participation eligibility or decline to review the entry.
6. For the purposes of competition display, educational promotion, and publicity, the School agrees that the Organizer may, in accordance with the Competition terms and relevant media consent forms, report, display, review, play, screenshot, publish, or otherwise use shortlisted, outstanding, or winning entries on the official website, social media, exhibitions, award ceremony, media coverage, and other related channels.
7. The School agrees that this form and the participation information may be used for competition administration, eligibility verification, entry display, exhibition handbooks, certificate production, awardee lists, and related communications. Please complete all information carefully, especially the school name, participating students' names, and certificate display information.
